Portland Flower Market Buyers Membership Rates:

➤ **Horticultural/Flower Trade Membership**

- \$25 – membership, first 3 Buyers Passes included, \$10 for each additional Buyers Pass (unlimited)
- Horticulture/Flower Trade Members are identified as Floral/Horticultural professionals, floral studios or event florist as indicated by their physical retail locations or their internet presence
- New Businesses meeting the above definition for Horticultural/Flower Trade Membership will start out as a Business to Business Membership for the first year and at renewal if the business can show it has spent a minimum of \$5,000 in product purchased at the Portland Flower Market then they will be renewed at this level.

➤ **Business to Business Membership**

- Business to Business Membership is identified as any company not identified as a Horticulture/Flower Trade Member is identified or a Club/Non-Profit
- \$100 – membership, 3 Buyers Passes included in membership
- \$200 – group memberships between 4-25 Buyers Passes, first 3 Buyers Passes included in membership, \$25 for each additional Buyers Pass

➤ **Club/Non-Profit Membership**

Limited shopping hours M, W, Th 10am-2pm; Tue 10am-Noon; Fri 5:30am-2pm; Sat 7-10am

- \$150 - membership, first 3 Buyers Passes included in membership.
- \$200 - group memberships between 4-25 Buyers Passes, first 3 Buyers Passes included in membership, \$25 for each additional Buyers Pass
